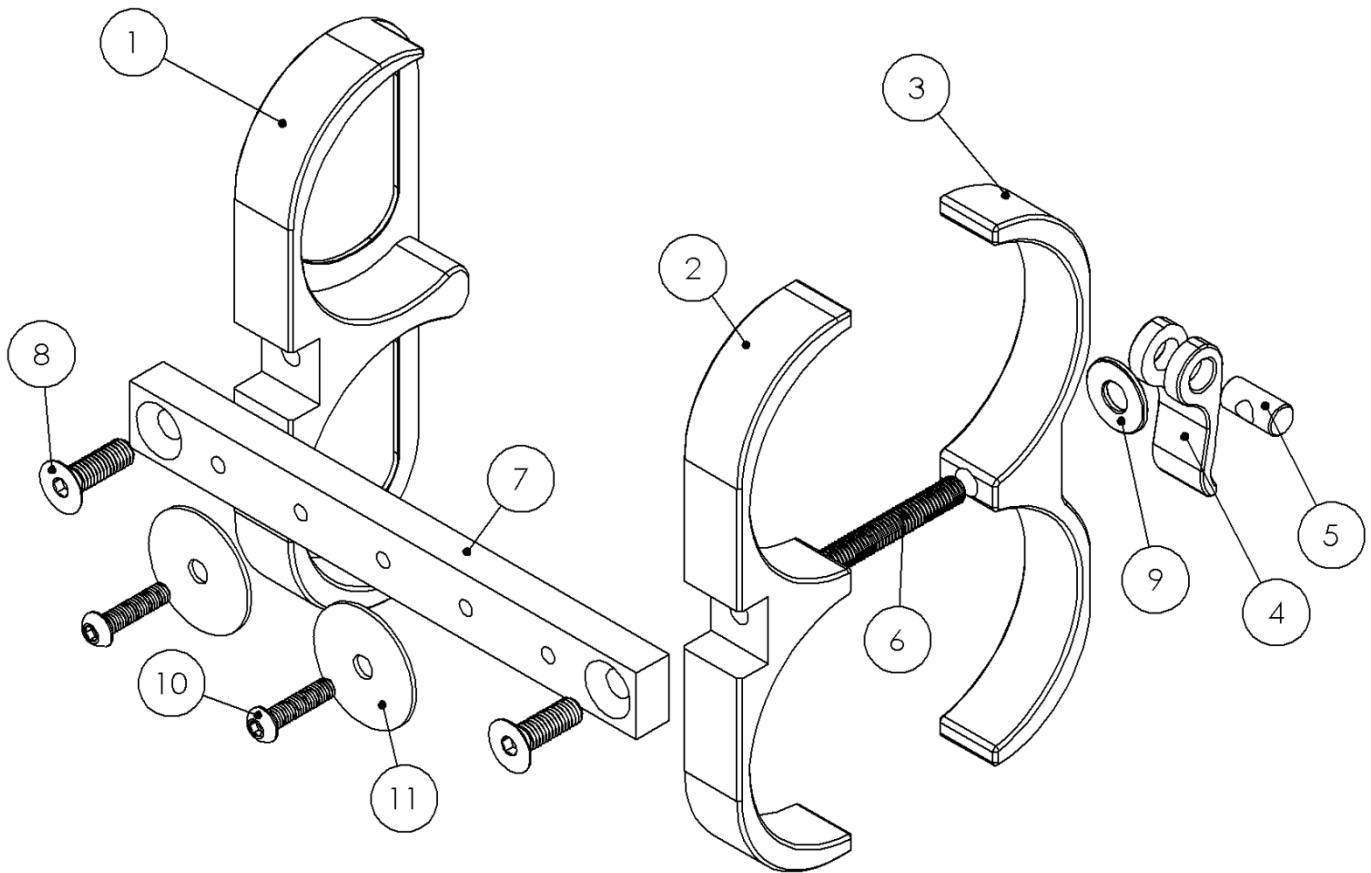

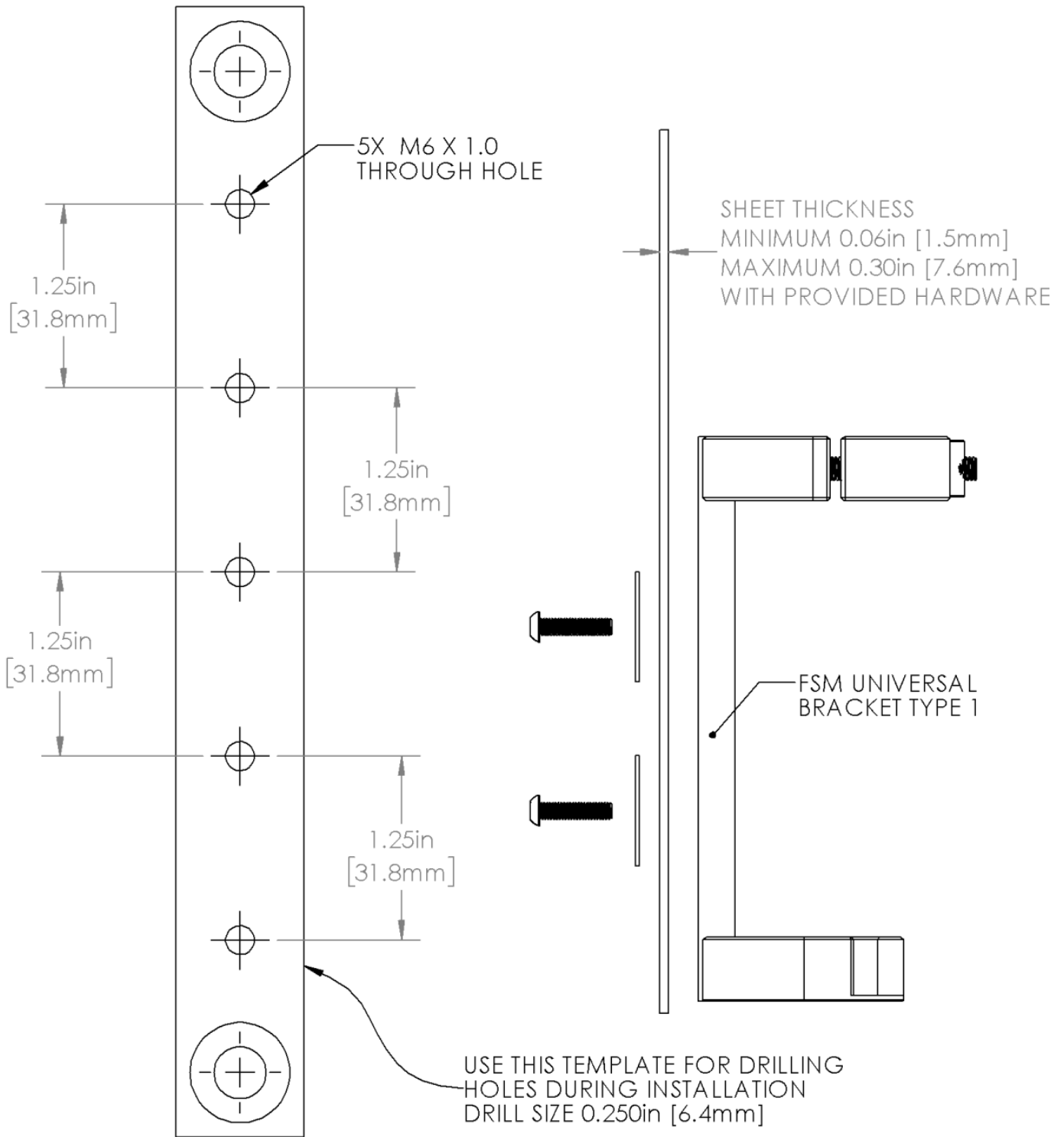

- b. 4mm HEX Wrench/Key
- c. TBD – Additional tools required based on the installation

## Universal Installation on Any Flat Surface

Assemble the universal fuel bottle mount per the exploded diagram on the parts list using the 5mm hex wrench. Items 10 and 11 are used for installing the mount to any flat sheet surface.
